Student Check and boarding will be from 6:30 to 7:00 pm. Hors d'oeuvres and beverages service will begin at 7:00 pm. The dance will conclude promptly at 10:00 pm. A detailed letter including information about conduct, parking, and pictures will be enclosed with the Tickets.

The dance you are attending is a school-sponsored event. All school rules and regulations apply while you are in attendance. Some of these will be spelled out in the following paragraphs, but so that there is no misunderstanding, you and your parents will sign the reverse of this contract, signifying that you have read and understood the information presented to you here.

- **If your date attends some school other than Seton-La Salle High School**, then there is a section on the reverse of this form that he/she must fill out. **He/she will also be required to present photo i.d. at the registration desk on the night of the dance.**
- Students who submit incomplete forms will not be sold a ticket to the dance.
- You, as a member of the Seton-La Salle community, are responsible for the behavior of your date.
- Also, your tuition payments to Seton-La Salle must be up to date if you are to attend.
- **If your date attends Seton-La Salle High School**, then he/she will submit a form identical to this one, except that you will be listed as the date. Until both forms are submitted no ticket will be sold to either party.
- Tuition payments must be up to date and all financial obligations must be met for both you and your date. If tuition payments are in arrears or there is an outstanding financial obligation for either party, then tickets to the dance will not be sold to you.

As per the student/parent handbook, the school administration reserves the right to refuse admission to any guest, including, but not limited to, former students of Seton-La Salle High School who were dismissed for disciplinary reasons.

- This is a **non-smoking** event. Please make your date aware of this. *Use or possession* of any tobacco products will not be tolerated.
- If you or your date are found to be in possession of tobacco products, your parents will be called and you will be sent home.
- The same applies to alcohol and other drugs, weapons, or anything else that is against the rules and policies of Seton-La Salle High School and/or the Diocese of Pittsburgh.
- Dancing must be appropriate and in keeping with the nature of a Catholic school. Any couple participating in sexually suggestive or otherwise inappropriate dancing will be asked to stop. Further incidents will result in the couple being sent home after a call to the parents.
